CONTRACT FOR GOLF OUTING

_____ ("Organization") requests the date of _____ for an _____ A.M. or _____ P.M. (see shotgun policy below) for a golf outing at PineCrest Golf Club, Inc., for _____ participants. The Organization and its authorized representative agree to the policies and regulations set forth by PineCrest Golf Club, Inc.

Policies and Regulations

1. **Deposit:** A \$500. deposit will be required for all shotgun or modified shotgun starts and a \$500. deposit is required for all other reservations. All full shotguns will require a minimum of 90 players and all modified shotguns will require a minimum of 72 players. *If you do not meet the minimums, you will be required to schedule tee times - NO EXCEPTIONS.* Part or all of the deposit may be forfeited if some of the times reserved are not used, thereby prohibiting others from using those times. This deposit, all or in part, may also be forfeited if there are any damages to carts or to the golf course by participants from this Organization.
2. **Confirmation:** Confirmation will occur upon receipt of contract and deposit. No later than **seven (7)** days prior to the outing, you will be asked to **confirm** the number of starting times you wish to reserve and the number of people attending the banquet function. **That number will represent the guaranteed number of starting times and the number of people for which you will be charged.** Each starting time represents four (4) outing fees. In the event that the outing has less players or people attending the banquet function than the guaranteed number, the Organization will be required to pay for the guaranteed number. This total may be deducted from the deposit. A listing of the participants will also be required **five (5)** days in advance.
3. **Cancellation:** Up to four (4) weeks before your event, you may cancel any or all of your reserved starting times without penalty and be entitled to a full refund of your deposit. Organizations canceling the event less than four (4) weeks prior to the date will forfeit the deposit. If weather or playing conditions require cancellation by the Club, rescheduling will be done at the Organization's convenience or all monies will be refunded. If the course is open you are responsible for the number of confirmed players given seven days in advance. If lightning occurs during your golf outing, all play will be suspended until danger passes.
4. **Dress Code:** PineCrest Golf Club, Inc. requires all participants must wear soft spike golf shoes, shirts with collars and sleeves, and appropriate slacks, shorts, or skirts. The following are deemed inappropriate golf attire and cannot be worn on Club premises: **jeans**, tank tops, halter tops, bathing suits, undershirts, cut-off sweatshirts, cut-off jeans. Persons deemed inappropriately dressed will not be able to play.
5. **Shotgun Starts:** Shotgun starts are available Monday through Thursday at 9:00 a.m. or 1:00 p.m. Friday shotguns are available at 8:00 a.m. only for those groups who want to have their meal upstairs in our banquet facility. Friday afternoon shotguns are only available to those groups who have their meal downstairs under our veranda. All full shotgun starts will require a minimum of 90 players. Modified shotguns are available for groups of 72 or more. If your group falls below the minimum requirements you must use tee times. **THERE ARE NO EXCEPTIONS!!**

CONTRACT FOR GOLF OUTING (page 2)

6. Miscellaneous:

- A. Food and beverages may not be brought onto the Club premises. *Outside alcoholic beverages and coolers are prohibited on the golf course and the club premises.* All arrangements for food and beverages must be made with the Outing Coordinator. All large golf outings will be required to have food and beverage service and guarantees must be communicated for all meal services. Cancellation of outings will incur food costs if not cancelled 72 hours prior to outing.
- B. The rental of golf carts is required for all outings and is included in the package prices. The Organization agrees to be responsible for all damages to golf carts while in possession of the participants. The club has the right to retain the deposit until such damages have been recovered.
- C. Any damages incurred by your participants to the clubhouse or any home located on the golf course will be the responsibility of the Organization. The club has the right to retain the deposit until such damages have been recovered.
- D. Individual stroke and scramble scoring is included in your package. Calloway scoring is available for an additional fee of \$1.00 per player.
- E. Unacceptable behavior will not be tolerated on the golf course, if necessary; those persons will be asked to leave the golf course without a refund.

7. The following services are available to you and your Organization upon request at no additional cost:

- a) Printed local rules of play.
- b) Contest (and proximity) markers - longest drive, closest to the pin, etc.
- c) Use of men's and women's locker and shower facilities.

8. Payment of Fees: Payment of all fees and any additional charges must be made on **the day of the outing.** You will be responsible for payment for the number of golfers confirmed seven days prior to your outing – no exceptions will be made. A 4% service charge will be added to all payments made by credit card.
